# **Community Meeting**

# Tuesday, March 11, 2025, 6:30 p.m.

**WELCOME/CALL TO ORDER**: The meeting was called to order at 6:38 p.m. by President Dr. Delta Bowers. Attendees were welcomed to the meeting.

COMMUNITY: Attendees repeated the Pledge of Allegiance to the flag.

**REVIEW/APPROVAL OF MINUTES 01/14/2025**: Copies of the minutes were distributed and read silently. *Motioned by Kent Walker to approve the minutes as received. Seconded by Natalie Randolph. Motion carried.* 

# NHCA BUSINESS

**SECURITY**: Henrico Community Police Officer Pfister reported the following: no reports of larceny or auto thefts; the bridge (a major undertaking) at Wilkinson Road is projected to open next month; re: apartments at Chamberlayne and 95 Officer Pfister will meet to discuss expectations such as safe environment, rental vs ownership, rental cost \$1,100 to \$1,200 per month unconfirmed; Telegraph Road units initially for purchase now opened for rentals; residents cautioned to be careful responding to texts that may be fraudulent scams – he will be happy to do a presentation.

The floor was opened to residents with response (*in italics*) from Officer Pfister. What are buildings and why is a car parked across from Bank of America? *Dog sniffing for vehicles entering area of Brook Villa*. What is the policy regarding fireworks every holiday? *The Fire Department marshals handle this matter*. *Call the FD non-emergency number with concern. Community Maintenance may be another resource to investigate*. Why was a barricade set up on Spring Hollow with police, fire trucks and ambulance presence? *Uncertain of situation, may have been a state matter*. What was cause of Hwy 95 backup? *An excavator hit the overpass*.

Officer Pfister was thanked for his presence and reporting.

**HABITAT FOR HUMANITY PROJECT**: Luis Chacon distributed and reviewed a flyer that announced free roof repair for qualifying Henrico County residents. Mr. Chacon was thanked for his presentation.

**COUNTY/COMMUNITY INITIATIVES**: Bill Schmidt, NHCA County Coordinator reported Word on the Street Newsletter is informative with updates (see website); Green City project is stalled and a \$5 million dollar payment to the County is late; a roundabout is under construction at St. Charles and Parham; Scotts Bridge has been torn down; bridge replacement at Lakeside Avenue is due to begin 2<sup>nd</sup> quarter of the year – street has been repaved; Dominion Energy is working on easements to install underground cables.

Residents raised questions or commented as follows with response (*in italics*) from Mr. Schmidt. What is status of proposed Data Center and will electricity cost go up for residents? *The Data Center is moving forward at a smaller scale.* Why was a crosswalk installed at Chamberlayne and Diane? No one has been seen using it. *The installation was in response to COVID with the expectation that people would be walking more. Use is expected to increase when the weather is warmer.* Can we get an elected official to

address residents' concern regarding construction of Rosie's at Staples Mills? *Construction of the facility followed required rules*. Considering construction of multiple apartments and homes in the area, why are taxpayers, not developers, responsible for schools? *It's the rule, but could be addressed with the County Board of Supervisors and the Planning Commission*.

Mr. Schmidt was thanked for his report.

NHCA MEMBERSHIP DRIVE UPDATE: Carmen Daugherty, VP Membership reported the following:

4 new payments (response to email reminders was disappointing)

\$95 less collected than last year this time. New NHCA brochures were available and distributed.

**TREASURER'S REPORT**: Phillip Kirby, Treasurer distributed and reviewed the Financial Report for the period ending February 28, 2025.
